

# Privacy Policy

This privacy policy has been compiled to better serve those concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, as used in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person or an individual in context. Please read our privacy policy carefully to understand how we collect, use, protect, or otherwise handle your Personally Identifiable Information per our website.

## What personal information do we collect from the people that visit our website?

## When do we collect information?

## **Do we use 'cookies'?**

## Fair Information Practices

The Fair Information Practices Principles form the backbone of privacy law in the United States. The concepts they include have played a significant role in developing data protection laws around the globe. Understanding the Fair Information Practice Principles and how they should be implemented is critical to comply with the various privacy laws that protect personal information.

To be compliant with Fair Information Practices, we will take the following responsive action should a data breach occur:

- We will notify users via email within 14 working days of discovering the breach.
- We will notify users via in-site notification within 72 hours of discovering the breach.

We also agree to the Individual Redress Principle, which requires that individuals have the prerogative to pursue legally enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires that individuals have enforceable rights against data users and recourse to courts or a government agency to investigate and prosecute non-compliance by data processors.

## CAN-SPAM Act

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells severe penalties for violations.

### We collect your email address to:

- Send information, respond to inquiries, and handle other requests or questions.

- Process orders and send information and updates pertaining to orders.
- Send you additional information related to your product and service.
- Market to our mailing list or continue to send emails to our clients after the original transaction has occurred.

## **To be in accordance with CAN-SPAM, we agree to the following:**

- Identify the message as an advertisement in some reasonable way.
- Include the physical address of our business or site headquarters.
- Monitor third-party email marketing services for compliance if one is used.
- Honor opt-out/unsubscribe requests quickly.
- Allow users to unsubscribe using the link at the bottom of each email.
